**Course Description**: The course focuses on the educational decisions, including individual choices, institutional strategies and government policies. It is an elective course in economics and it is designed for junior and senior students.

During the first part of the course we will go over the mathematical and empirical tools needed to understand and perform quantitative analysis on topics in the economics of education. Students should expect to work on optimization methods, regression analysis and causal inference analysis.

After we have built a solid foundation of empirical and theoretical knowledge, we start thinking about educational decisions, including individual choices, institutional strategies, and government policies. We begin by framing education choices within a model of investments in human capital. Topics include measuring the costs and returns of education from an individual and public policy perspective, the relationship between education and inequality, and the role of K-12 and post-secondary institutions in economic growth.
